## **Construction and engineering**

Patrick Heneghan is a senior construction and engineering disputes specialist with extensive experience in high-value, complex litigation and arbitration. He is widely recognised for his expertise in handling professional negligence claims, large-scale infrastructure disputes, and cross-border arbitration, with particular focus on matters before the Technology and Construction Court (TCC).

Patrick sits on the **TCC Users Committee**, reflecting his standing within the specialist forum for construction disputes in England and Wales. He is also highly experienced in proceedings under the leading standard form contract suites (including **JCT**, **NEC** and **FIDIC**) and regularly advises on disputes arising under professional appointments (such as **RIBA PSC**, **ACE PSA** and **RICS SFCA**).

He has acted in numerous international arbitrations under all the major institutional rules (including **LCIA**, **ICC** and ad hoc arbitrations), and across a variety of seats, with a strong track record of advising clients in the energy, power, infrastructure, and real estate sectors. His arbitration practice covers both claimant and respondent side mandates, often involving multijurisdictional issues, delay and disruption claims, liquidated damages, and force majeure.
