Care and adoption

- Non-Accidental Injury and Child Death: Kara is regularly instructed to represent clients in cases involving serious allegations of physical harm to children, including those resulting in death.
- Factitious or Induced Illness: She has experience in cases where caregivers intentionally cause or exaggerate illness in children, requiring careful analysis of extensive medical evidence.

Injunction Applications

Kara also represents clients in injunction applications within both care and adoption proceedings, acting for applicants and respondents. She handles these matters with sensitivity, recognising the urgency and emotional turmoil that often accompanies such cases.

Private law children

Kara has additional expertise in wardship proceedings and in applications pursuant to the inherent jurisdiction, including in cases of international abduction.

In injunction proceedings, Kara represents both applicants and respondents in applications for both forced marriage and female genital mutilation protection orders.
