- Duration (s.25(2)(d) MCA).
- Short Marriages

"Thus, in my judgment where a relationship moves seamlessly from cohabitation to marriage without any major alteration in the way the couple live, it is unreal and artificial to treat the periods differently"

Per Mostyn J in GW v RW [2003] EWHC 611

Kimber v Kimber

- Are the parties living together in the same household?
- Does living together involve a sharing of daily tasks and duties?
- Is there a stability and permanence in the relationship?
- Are the financial affairs of the couple indicative of their relationship?
- Is there a sexual relationship?
- What is the relationship between the parties and children who are not theirs?
- How is the relationship presented publicly?
- What would the opinion of a reasonable person with normal perceptions be of the relationship?





Cohabitation: Principles

- Engagement per se is ignored
- Normally (but not necessarily) living together
- Analysis derived from 'markers':
 - Sex
 - Money
 - Intentions & Quality
 - Commitment
 - Mutual Support

"In the end, it is a fact specific inquiry. Human relationships are varied and complex; they do not easily lend themselves to pigeon holing.

The essential inquiry is whether the premarital relationship is of such a nature as to be treated as akin to marriage."

Separation and the End

 'That analysis can be applied to an attempt to define the date of the end of the marriage as much to its commencement.'



What is a Short Marriage?

- Dictionary of Financial Remedies 2022 at p.32
- No reference in MCA.
- Inappropriate to be too precise.
- 3 years is properly characterised as short; but see table in handout.
- Ultimately, it is a broad assessment.



Calculation of Assets

- Thorpe LJ in Cowan v Cowan [2002] Fam 97 at [70].
- Mostyn J in E v L

'In my experience convention and tradition dictate that save in cases where there has been undue delay between the separation and the placing of the matter for trial before the court, the end date for the purposes of calculation of the acquest should be the date of trial'.

... H offered job at ABL.

... Parties Separate.

... ABL listed publicly [\$450-\$700] [\$315-490M]
